






### BC FEDERATION OF LABOUR BC VIEWS ON THE MINIMUM WAGE

### Methodology



- The results included in this presentation are based on an online study conducted from March 13 to March 16, 2015, among 811 British Columbians aged 18+ who are Your Insights panel members.
- Your Insights is Insights West's in-house access panel offering on-demand samples for both clients and research suppliers looking for Western Canadian populations. The data has been statistically weighted according to Canadian census figures for British Columbia for age, gender and region.
- Results have a margin of error of ±3.5 percentage points, 19 times out of 20.









# More than a third of British Columbians (37%) favour a slight increase to the minimum wage—45% think the increase needs to be significant.

#### Views on the Whether an Increase is Required








# Four-in-five (83%) think it is necessary for a person making minimum wage in British Columbia to live above the poverty line.

#### Minimum Wage and the Poverty Line


A person working full time in BC and earning the minimum wage is living nearly \$6,000 below the poverty line. Thinking about this do you think it is necessary to ensure that a person making the minimum wage in British Columbia lives above the poverty line?





# Three-in-four British Columbians (76%) support raising the minimum wage to \$15 an hour in the province

#### A \$15 an hour Minimum Wage


A \$15/hr wage would put a full-time worker's earnings just above the poverty line. Currently there are over half a million working people in BC earning less than \$15 an hour. Thinking about this, do you support or oppose raising the minimum wage to \$15 an hour in BC?





# Two thirds of British Columbians (65%) want the provincial government to put a plan in place to reach a \$15 an hour minimum wage.

#### Establishing a Plan for \$15 an hour




There are a several jurisdictions in North America that have committed to a \$15/hr minimum wage, including the Province of Alberta, the State of New York and the cities of Seattle, San Francisco and Los Angeles in the United States. Thinking about this, do you agree or disagree with the Government of British Columbia putting a plan in place to reach a \$15/hr minimum wage?





# At least two thirds of residents consider a \$15 an hour minimum wage as "fair" (74%), beneficial to the economy (71%) and acceptable (68%).


From what you have seen, read or heard, do you agree or disagree with each of the following statements?


Voters in British Columbia will take part in a provincial election in May 2017. Will you be looking for political parties to commit to raising BC's minimum wage as part of their election commitments?

#### Provincial Poverty Reduction Strategy




